Our youth experience summers building and performing the annual ski show, hosting community events, and participating in teambuilding and social activities. The CLSC fosters the development of lifelong friendships and the appreciation of continuing the special legacy of the Clear Lake Community. Additionally, our Ski School provides a unique opportunity for Clear Lake youth to develop and experience water sports disciplines not available otherwise. The Ski School will continue to teach our members show skiing, pyramid building, ballets, crosses, jumping, barefooting, riding a disc, air chair, and more.

Needs

To continue this special tradition, the CLSC and Ski School face immediate needs requiring further investment. The majority of the ski equipment has not been updated in over 20 years. Some of these needs include:

- Expanding equipment needs to accommodate show skiers.
- Repairing and enhancing existing equipment.
- Enhancing the safety and technology capabilities of equipment.
- Replenishing and rebuilding show ropes.
- Maintaining the jump and storage facilities.
- Increasing skier capacity for the 60th Anniversary Ski Show!

The Plan

Raise \$20,000. This fundraising will accelerate preparations for the 60th Anniversary Ski Show as well as meet the current and ongoing needs of the CLSC and Ski School. Ideally, the capital campaign would raise the first \$10,000 by Jan. 31, 2019 and the second \$10,000 by June 1, 2019. The necessity for the first \$10,000 is the vendor manufacturing jump skis and related jump supplies informs us the various equipment is on back order for approximately 4-5 months. Therefore, the equipment must be purchased by Feb. 1 in order to have it by June.
